

Public Hearing for Solid Waste Management Plan Update

Bedford County, Fulton County, and Huntingdon County will hold a joint Public Hearing on the proposed 2021 Municipal Solid Waste Management Plan Update. The Public Hearing will be held virtually on October 6, 2021 at 7:00 pm. The purpose of the hearing is to provide an opportunity for residents, businesses and municipal officials who may have questions or recommendations for the 2021 update to the Municipal Solid Waste Management Plan (Plan Update).

The Plan Update includes information concerning the solid waste and recycling regulations, definitions and projections of solid waste and recycling. The update also includes information on the following participating facilities Cumberland County Landfill, Mostoller Landfill, Sandy Run Landfill, Southern Alleghenies Landfill, Mountainview Reclamation Landfill, Laurel Highlands Landfill, and Wayne Township Landfill, as well as Mifflin County Transfer Station, Altoona Transfer Station, Dale Summit Transfer Station, Breezewood Transfer Station, and Park's Transfer Station.
