

GIS UCC EXEMPT WORK NOTICE

A building permit is required for any individual who intends to construct, enlarge, alter, repair, move, demolish or change the occupancy of any building, or erect, install, enlarge, alter, repair, remove, convert or replace an electrical, gas, mechanical or plumbing system regulated by the Uniform Construction Code.

An emergency repair or replacement of equipment may be made without first applying for a permit, but an individual must submit an application to the building code official within 3 business days of such a repair.

A building permit is NOT required for the following residential construction, repair or replacements, if the work does not violate a law or ordinance:

- Fences that are less than 6 feet high.
- Retaining walls less than 4 feet high, unless the wall is used for structural bearing.
- Water tanks less than 5,000 gallons that are supported directly upon grade.
- Sidewalks and driveways that are 30 inches or less above grade and not placed over a basement or story below it.
- Exterior or interior painting, papering, tiling, carpeting, flooring, cabinets, counter tops and similar finish work.
- Prefabricated swimming pools that are less than 24 inches deep.
- Window awnings that are supported by an exterior wall and do not project more than 54 inches from the wall.
- Replacement windows and doors that do NOT require any framing alteration.
- Replacement of existing roofing material if less than 25% of total roof area is replaced in any 12-month period.
- Replacement of existing siding.
- Repair or replacement of any part of a porch or stoop which does NOT structurally support a roof located above it.
- Installation of additional roll or batt insulation.
- Replacement or exterior rainwater gutters and leaders.
- Installation of an uncovered deck where the floor of the deck 30 inches or less above grade.

Exempt minor electrical work:

- Replacement of lamps or the connection of approved portable electrical equipment to approved permanently installed receptacles.
- Replacement of a receptacle, switch or lighting fixture that is rated 20 amps or less and not required to be ground fault.
- Replacement of installed electrically operated equipment such as doorbells, communication systems and motor operated device.
- Installation, alteration or rearrangement of communications wiring.
- Replacement of dishwashers.
- Replacement of kitchen range hoods.
- Installation of battery powered smoke detectors.

Exempt gas work:

- Portable heating, cooking or clothes drying appliances.
- Replacement of a minor part that does not alter approval of or make equipment unsafe.
- A portable fuel cell appliance that is not connected to a fixed piping system and is not interconnected to a power grid.

Exempt mechanical work or equipment:

- A portable heating appliance.
- Portable ventilation appliance or cooling unit.
- Steam, hot or chilled water piping within heating or cooling equipment.
- Minor part replacement that does not make equipment unsafe.
- Self contained refrigeration systems that contain 10 lbs. or less of refrigerant or are put into action by motors of not more than 1 horsepower.
- Portable evaporative cooler.
- A portable fuel cell appliance that is not connected to a fixed piping system and is not interconnected to a power grid.

Exempt plumbing work:

- Replacement of bib valves, if the replacement valves are provided with an approved vacuum breaker.
- Refinishing of existing fixtures.
- Repair of leaks and clearance of stoppages.
- Replacement of faucets, traps, water closets, lavatories, kitchen sinks, domestic clothes washers and dishwashers and valves other than shower or combination shower/bath valves.

Exempt heating, ventilation and air conditioning work:

- Replacement of motors, pumps and fans of the same capacity.
- Repair and replacement of heating, supply and return piping and radiation elements, which do not require rearrangement of the piping system.
- Repair and replacement of air conditioning equipment and systems, control devices for heating and air conditioning equipment and ductwork.
- Replacement of kitchen range hoods.
- Replacement of clothes dryers, stoves or ovens provided that there is no change in fuel type, location or electrical requirements.

The following are not ordinary repairs and do require a UCC permit:

- Cutting away a wall, partition or portion of a wall.
- The removal or cutting of any structural beam or load bearing support.
- The removal or change of any required means of egress, or rearrangement of parts of a structure affecting the egress requirements.
- The addition to, alteration of, replacement of any standpipe, water supply, sewer, drainage, drain leader, gas, soil, waste, vent or similar piping, electric wiring or mechanical device, unless it is listed in the exclusions above.

General UCC Exemptions:

Existing buildings, detached uninhabitable accessory structures under 500 sq. ft., carports, greenhouses and historical buildings.
