

The regular meeting of the Huntingdon County Commissioners was held on the above date and time in the Commissioner's Meeting Room with the following present: Commissioners Walls, Thomas, and Reeder; Solicitor, Larry Newton; Chief Clerk, Heather Fellman; Probation Director, Len Hahn; Commissioners' Office Inter, Jackson Sharpe; Planning Director, Laurie Nearhood; Daily News Reporter, Joe Thompson and guests: Jodi Skipper, Scott Mettelle, Sherry Perow, Taylor Walters, Linda White, David Gardner, Dwight Hill, and Justin Capouellez.

The meeting was called to order at 9:30 a.m. by Commissioner Walls. Prayer was led by Commissioner Walls and the Pledge of Allegiance to the flag was led by Reeder.

It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Walls, yes; Reeder, yes) to approve the minutes of the previous meeting.

It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Reeder, yes; Walls, yes) to approve payment of bills.

There was one addition to the agenda: a county-wide burn ban. It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Walls, yes; Reeder, yes).

There were no announcements.

There were no public comments.

There were no matters to be addressed by the Solicitor.

Under new business, Justin Capouellez from the Pennsylvania Association of Realtors requested consideration of approval for a declaration for Fair Housing Month. It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Reeder, yes; Walls, yes).

Len Hahn, Probation Director, requested consideration of approval to hire Grayson McClain for the position of full time Probation Officer effective 4/7/2025. It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Walls, yes; Reeder, yes).

Jodi Skipper from DCNR requested consideration of approval for Resolution 9-2025 for a burn ban which will go into effect on 4/3/2025 at 9:45 am. The next couple of weeks there is a high fire danger. No precipitation is expected after this weekend for the next three weeks and we have had below average rainfall this year. It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Reeder, yes; Walls, yes).

Laurie Nearhood, Planning Director, requested consideration of approval for a service agreement with SCCSWA and Community Refuse Service, LLC. It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Walls, yes; Reeder, yes).

Laurie Nearhood requested consideration of approval for a service agreement with SCCSWA and Clinton County Solid Waste Authority. It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Reeder, yes; Walls, yes).

Consideration of approval was given for Marc Service Inc. change order #4 for a time extension of 66 days. It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Walls, yes; Reeder, yes).

Consideration of approval was given for K&K Plumbing change order #7 for a time extension of 66 days. It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Reeder, yes; Walls, yes).

Consideration of approval was given for Penn State Construction change order #16 for additional wall covering and base for Courtroom 1. The total cost of this change order is \$12,536.85. Courts have agreed to reimburse the County for these charges. It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Walls, yes; Reeder, yes).

Consideration of approval was given for Penn State Construction change order #17 for window frame repairs. The total cost of this change order is \$2,160.70. It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Reeder, yes; Walls, yes).

Consideration of approval was given for Penn State Construction change order #18 to replace a water line. The total cost of this change order is \$2,308.78. It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Walls, yes; Reeder, yes).


There were no Matters for Action.
