#### RESOLUTION NUMBER 2024 - 2

#### ADOPTION OF THE *HUNTINGDON COUNTY ACTIVE TRANSPORTATION PLAN* AS PART OF THE *HUNTINGDON COUNTY COMPREHENSIVE PLAN*

WHEREAS, the Pennsylvania Municipalities Planning Code (Act 247) requires counties to prepare and adopt comprehensive plans; and

WHEREAS, the Huntingdon County Board of Commissioners is committed to fostering proper growth and development through effective planning to ensure the enjoyment and quality of life of each citizen; and

WHEREAS, the Huntingdon County Commissioners adopted a county comprehensive plan on July 11, 2000 and a multi-county comprehensive plan on July 3, 2018; and

WHEREAS, the adopted Comprehensive Plans identify critical issues facing Huntingdon County, in the areas of broadband and cell service; business, economic and workforce development; natural resources and conservation; housing and blight; land use; community services and facilities; historical resources; recreation and cultural assets; transportation; and communication, coordination and collaboration; and

WHEREAS, the Huntingdon County Active Transportation Committee appointed by the Huntingdon County Commissioners has developed a *Huntingdon County Active Transportation Plan*; and

WHEREAS, the Huntingdon County Commissioners adopted the *Huntingdon County Active Transportation Plan* on September 12, 2023 as a stand-alone plan; and

WHEREAS, the required public meeting and public hearing have been held by the Huntingdon County Planning Commission and the Huntingdon County Commissioners; and

WHEREAS, the Huntingdon County Planning Commission has recommended adoption of the amendment to the Huntingdon County Comprehensive Plan, which consists of the *Huntingdon County Active Transportation Plan* containing ten priorities that fit the goals of active transportation planning and that resonated with the Huntingdon County Active Transportation Committee. These ten priorities, including maps, charts, textual matter, and other matters forming the plan, are directed at improving walking and biking conditions in Huntingdon County.

NOW, THEREFORE, BE IT RESOLVED, that the *Huntingdon County Active Transportation Plan* dated September 2023 is hereby adopted by the Huntingdon County Commissioners as part of the official Comprehensive Plan for Huntingdon County.


