The regular meeting of the Huntingdon County Commissioners was held on the above date and time in the Commissioner's Meeting Room with the following present: Commissioners Thomas and Reeder; Chief Clerk, Heather Fellman; Solicitor, Larry Newton; Planning Director, Laurie Nearhood; EMA Director, Katie Unger; Probation Director, Len Hahn and Daily News Reporter, Byron Mantoan.

The meeting was called to order at 9:30 a.m. by Commissioner Reeder. Prayer was led by Commissioner Thomas and the Pledge of Allegiance to the flag was led by Commissioner Reeder.

It was moved by Commissioner Thomas, seconded by Commissioner Reeder and carried (Thomas, yes; Reeder, yes) to approve the minutes of the previous meeting.

It was moved by Commissioner Thomas, seconded by Commissioner Reeder and carried (Thomas, yes; Reeder, yes).


There were no Matters for Action.
