Notice is hereby given that the Huntingdon County Planning Department on behalf of the Huntingdon County Commissioners, Huntingdon Borough and Smithfield Township will hold the second (2<sup>nd</sup>) public hearing to discuss and receive comments on the FFY 2022 CDBG application for on Thursday October 6, 2022 at 5:30pm at the Courthouse Annex 1 Building, first floor, 205 Penn Street, Huntingdon PA 16652.

The following projects will be considered for funding consideration at the hearing and will be approved at the local level by resolution by each municipality prior to the submission of the application.

Huntingdon County's 2022 CDBG allocation is \$243,006.00 for funding of the following projects

- Pennsylvania Avenue Restoration
- MUMA W Davis/W Garber Waterline Improvements
- Program Administration Funds

Huntingdon Borough's 2022 CDBG allocation is \$125,988.00 for funding of the following projects

- Huntingdon Community Center ADA Accessibility
- Program Administration Funds

Smithfield Township's 2022 CDBG allocation is \$101,401.00 for funding of the following projects

- Housing Rehabilitation
- Program Administration Funds

At least 70% of the available funding must be used for activities that benefit low/moderate income persons in the service area to qualify as a low-moderate income project.

Pursuant to approval by the Huntingdon Borough Council, Smithfield Township Supervisors and the Huntingdon County Commissioners and after consideration of all comments received by the public, the Huntingdon County Planning and Development Department will submit the application to the Pennsylvania Department of Community and Economic Development (PA-DCED) for approval.
