

The regular meeting of the Huntingdon County Commissioners was held on the above date and time in the Commissioner's Meeting Room with the following present: Commissioners Walls, Thomas, and Reeder; Solicitor, Larry Newton; Chief Clerk, Heather Fellman; Sheriff, Jeff Leonard; Daily News Reporter, Joe Thompson; ABATE members, Helen Cohenour, Becky Smith, Paul Cannon, Pam Franks, Brenda Shields, Art Erikson, and Kate Hughes.

The meeting was called to order at 9:30 a.m. by Commissioner Walls. Prayer was led by Commissioner Reeder and the Pledge of Allegiance to the flag was led by Walls.

It was moved by Commissioner Reeder, seconded by Commissioner Thomas and carried (Walls, yes; Thomas, yes; Reeder, yes) to approve the minutes of the previous meeting.

Under new business, consideration of approval was given for Proclamation 6-2025 for Motorcycle Safety and Awareness Month. It was moved by Commissioner Thomas, seconded by Commissioner Reeder and carried (Walls, yes; Thomas, yes; Reeder, yes).

Consideration of approval was given for Kelsey Dunn, Register and Recorder, to attend the PA Recorder of Deeds Conference. The total cost is \$400. It was moved by Commissioner Reeder, seconded by Commissioner Thomas and carried (Thomas, yes; Reeder, yes; Walls, yes).

Jeff Leonard, Sheriff, requested consideration of approval for a contract with the Raystown Lake Army Corps of Engineers for law enforcement services. This program operates at no cost to the county. It was moved by Commissioner Thomas, seconded by Commissioner Reeder and carried (Reeder, yes; Walls, yes; Thomas, yes).


There were no Matters for Action.
