It was moved by Commissioner Fluke, seconded by Commissioner Thomas and carried (Thomas, yes; O'Korn, yes; Fluke, yes) to approve the hiring of Barry Morder as part-time corrections officer effective February 14, 2012.

There were no county veteran burial allowances for approval today.
