The meeting was called to order at 9:30 a.m. by Commissioner Sather followed by prayer led by Commissioner Walls and the Pledge of Allegiance to the flag led by Commissioner Thomas.

It was moved by Commissioner Walls, seconded by Commissioner Thomas and carried (Sather, yes; Walls, yes; Thomas, yes) to approve the minutes of the February 7th public meeting.

It was moved by Commissioner Thomas, seconded by Commissioner Walls and carried (Thomas, yes; Sather, yes; Walls; yes) to approve the addendum to the purchase of service agreement with Centre County Youth Services Bureau for a period of July 1, 2016 through June 30, 2017.

Dawn Sunderland submitted a request to re-appoint Theresa Brannigan to the Housing Authority Board. Ms. Brannigan is nearing the end of her initial five year term and is willing to serve a second term. It was moved Commissioner Walls, seconded by Commissioner Thomas and carried (Sather, yes; Walls, yes; Thomas, yes) to re-appoint Theresa Brannigan to the Huntingdon County Housing Authority Board for a term of five years.

There were 4 Veteran Burial Allowances for approval today.
